# 7 MATTERS ARISING

Cllr Parker provided an overview on the proceedings of the appeal that was held on 27<sup>th</sup> June 2017 in relation to Appeal Ref: APP/N2345/W/17/3167436, Land off Garstang Road, Barton, Preston PR3 5DP for the proposed erection of up to 45 houses by Wainhomes.

Many thanks to Andrew who attended 2 days of the appeal hearing and who spoke really well and to Steven who also gave evidence. Cllr Parker also thanked Mr Thorpe for his planning comments which supported the parish council's defence.

Cllr Parker reported that Preston City Council had also provided a robust defence with a significant buffer demonstrated on the 5 year housing supply.

Barton Parish Council had written to Preston City Council to thank them for their due diligence and support on the appeal.

# 9 ACCOUNTS FOR PAYMENT

The parish council had received a request from Myserscough & Bilsborrow Parish Council for a contribution towards the war memorial fund and the parish council agreed to pay the requested contribution of £170 to support the memorial.

It was agreed to pay £626 to the clerk for wages and expenses covering April-July. From August the salary will be paid monthly by direct debit at an amount of £156 per month.

The clerk asked for approval for an additional payment of £9.49 to Zurich Insurance following a slight underpayment made on the initial cheque. This was agreed.

### 11 BOARS HEAD UPDATE

Councillors were informed that an offer had been made for the Boars Head but this had been declined by the current owners who had responded to say that no offers would be accepted only the full asking price. It is understood that the pub will be put back up for sale to interested parties.

#### 12 NEIGHBOURHOOD PLAN UPDATE

The Barton Neighbourhood Plan will be presented to Cabinet for discussion on Wednesday 16<sup>th</sup> August 2017. If approved the Parish council can proceed to the next stage which will involve consulting with parishioners and businesses. An update will be provided at the next meeting.

#### 13 PRESTON CITY COUNCIL GREENSPACES CONTRIBUTION

The clerk informed Councillors that Preston City Council had written to the Parish Council to ask for a contribution towards the maintenance of green spaces within the borough. The contribution requested from Barton IS £1449.

Councillors agreed that should Barton Parish Council choose to accept the request and make the contribution that the precept would need to rise in order to cover this.

It was also reported at this stage that Wainhomes have requested permission from Preston City Council to access Station Lane Playing Fields via a new path that would be constructed. Barton Parish Council are unhappy with this request especially if an increase in liability for the playing fields is accepted in the future.

# 14 Parish Plan Presentation (Village Maintenance)

Cllr G Jolliffe expressed his disappointment at how the village looks in comparison to other villages in particular Bilsborrow which looked exceptional this year after receiving a grant towards planting for the village in bloom competition.

It was agreed that Barton needs to look critically at what it wants and develop a plan for this.

# 15 Parish Lengthsmen Scheme information report and discussion items

Broughton Parish Council had approached Barton Parish Council about the possibility of running a shared parish lengthsman scheme across both parishes. Barton Parish Council discussed the benefits of having a parish lengthsman and it was agreed in principle to go forward with a scheme subject to discussions with Broughton Parish Council about the detail.

Barton Parish Council have asked Preston City Council if Station Lane Playing Fields can be registered as a Fields in Trust. At the time of the meeting Barton Parish Council were awaiting a reply from Preston City Council.

## • Footpath Issue on Jepps Lane

The clerk had sent an email to the public rights of way officer at LCC regarding concerns expressed by a parishioner over drainage issues in the newly laid footpath joining Jepps Avenue to Forest Grove. At the time of the meeting no reply had been received.

# • Traffic Calming Measures off Jepps Lane

The Chair let the meeting know that an officer had now been assigned to deal with the issue of the speed bumps on Jepps following concerns expressed by parishioners that the speed bumps were excessive and could potentially cause harm to vehicles.

Barton Parish Council will continue to chase this issue up with LCC.

# • Traffic Safety Letter to LCC update

Cllr S Whittam was in the process of trying to organise a meeting with LCC to discuss a highways strategy for the A6. Cllr G Jolliffe had received a response to his letter highlighting his concerns but the letter did not seek to address any of the concerns raised. It is agreed that when a meeting is arranged the issue of road furniture and features and speed limits needs to be discussed in detail.
