As you may have heard, in November the Government announced the potential for an historic devolution deal for Lancashire which if approved would transfer new money and powers from central government to a newly created Combined County Authority. It would give local leaders extra powers to tackle key priorities such as better public transport, boosting economic prosperity and improving employment and skills as well as giving Lancashire a stronger voice on the regional and national stage. The County Council is keen to hear what people in Lancashire think about the devolution proposal, and there is more information about how to take part in the consultation in this newsletter.

I am pleased to say that we have received excellent feedback from the Parish and Town Council Conference which was held in November at County Hall. We had record numbers attending this year, mainly in person with some delegates attending via Teams. We've included a Frequently Asked Questions section in this newsletter to answer some of the questions that were asked at the conference that other parish and town council representatives might find useful. The annual Conference is part of our wider work to develop the relationship between LCC and parish and town councils in the County and next year we will be working on a refresh of the 'Working Better Together' Parish and Town Councils' Charter.

We live in challenging times and there are many pressures on all of us. Again this year the County Council is providing warm and welcome spaces in our libraries, and I know many parish and town councils also offer a warm and welcome space. There's more information in the newsletter about this and the wider package of winter wellbeing support available.

## Lancashire Devolution Deal



In November 2023, the Government announced it would be willing to enter into a devolution deal with Lancashire County Council, Blackburn with Darwen Council and Blackpool Council.

The deal, if given final approval, will transfer new money and powers from central Government to a newly created Combined County Authority, allowing it to tackle key local priorities.

The deal would not require a change to the established democratic structures across the county or the need for an elected mayor. It will not require an extra charge on council tax.

The county council wants to hear what you think about the draft devolution proposal and is keen to get as many views as possible. Individual responses to the consultation from parish councillors and local residents are very welcome, as we appreciate that submitting a collective council response may be difficult in the timescale. Please forward this information on to your parish councillors and consider including the information on your website as soon as possible, as the consultation will run until **26 January 2024**.



Anyone who lives or works in Lancashire, as well as businesses and other interested parties can give their feedback. The consultation is your chance to learn about the proposal, understand how it could affect the region, and have your say.

Gathering your views and ideas is important to us, to make sure the deal meets the aspirations and priorities of the county.

## National Databank – Free SIM Cards



Lancashire libraries are helping tackle digital poverty as part of the National Databank scheme which provides free SIM cards from Virgin Media O2, Vodafone and Three.

The SIM cards have mobile data, minutes and text. This scheme works with Good Things Foundation's network of local community partners including our libraries. You can qualify for data from your local library if you are over 18, are from a low-income household, and:

- have no access or insufficient access to the internet at home
- have no or insufficient access to the internet when away from home
- cannot afford your existing monthly contract or top up

To benefit from the scheme, a recipient's device must either be unlocked or, if locked, be locked to O2, Vodafone or Three.

## Parish Conference FAQs

November saw the annual Lancashire Parish and Town Council Conference, held at County Hall.



The programme included presentations on services and developments of interest to local councils including: road surfacing technology and innovation; Lancashire Electric Vehicle Infrastructure Strategy; footpaths, bridleways and byways; planning and preparing for flooding in Lancashire; anti social behaviour and rural crime.

We've pulled together some of the questions asked with responses which may be of interest to everyone, plus links to further information on the Lancashire County Council website:

### **Q: How and who prioritises when a road needs repairing and the timings of the repair?**

A: In March each year Cabinet consider the proposed Highways maintenance programme for the following financial year. Appendix B of the report states the criteria used to assess priority of each road class. The prioritisation is conducted by the Highways Asset Team who then pass a prioritised list of roads to be treated and the Countywide Projects Team will initially cost up and once approved then plan and undertake the works, taking into account time of year, type of treatment and the location. Defect repairs are assessed as they come in and prioritised and programmed on a daily basis based on the criteria set out in the Highway Safety Inspection Policy: [Highway safety inspection policy - Lancashire County Council](#)

### **Q: What is the timetable for gully cleaning and are details available on the LCC website?**

A: Gully cleansing is carried out in 2 ways. Approximately 112,000 of the highest priority gullies are cleaned cyclically either annually (priority 1) or bi-annually (Priority 2). Whilst each cyclically cleaned gully will have a date by which it must be cleaned in order to ensure it is done within one or two years, the work is programmed flexibly to ensure the best use of the available resources and to manage any weather events or work around access issues.

Any gully can be cleansed reactively, and cleansing is carried out within 22 working days or 4 hours if an emergency.





Given the need to be flexible we are unable to provide programme dates on the Council website. On request we can confirm which gullies are cyclically cleaned and the date by which it will be cleaned.

**Q: What is the resolution process for Public Rights of Way and how is the person who reported the issue updated?**

A: When a defect or obstruction is reported to LCC the PROW team send an email to acknowledge the report (if the customer's email address is provided) which reflects the text of the report to ensure it is logged it correctly. It can take some time to resolve issues both due to the number of outstanding reports and the nature of the necessary works, which is a combination of practical work, mapping and legal.

Public rights of way generally run over private land so often we need to find landowners or other interested parties, research the legal line, width and structures (which may be different from that on the ground) and take into account factors such as ecology, ground conditions and land use when choosing a solution and sometimes we need to serve Notice or take other enforcement action for a seemingly simple matter. It may take some time, therefore, before we can email the customer with details of the resolution.

**Q: What plans are in place to mitigate effects and impact of global warming in Lancashire?**

A: LCC's Environment and Climate Strategy sets out action the authority is already taking and maps out further improvements we will make over the next three years.
